


IMPACT REPORT

Because of alumni generosity, we have been able to fund several new projects at the Institute, including the Student Activity Center, Foundation Scholarship, School of Decision Sciences and Engineering, Convention Center, IIT (BHU) Main Library, the Advanced Vibration Lab, a new Entrepreneurship Fund, an Endowed Chair in the Metallurgy Department, and a Lecture Hall Complex.

1. Nikesh Arora (1989, EEE), in conjunction with Palo Alto Networks, donated a total of \$2M to establish the Access Fund, a needs-based scholarship for students preparing for technological careers.

His donation has enabled full ride scholarships for 21 students in the 2021-2022 session, 22 students in the 2022-2023 session, 34 students in the 2023-2024 session, and 36 students in the 2024-2025 session to attend IIT (BHU) for a total of 113 scholarship recipients as of 2025.

The Foundation maintained its fiduciary responsibility to ensure that investment returns would be sufficient to support these students for four years covering fees and medical insurance. We believe that it is important to encourage more women in STEM, especially those who are economically disadvantaged.
